

2024 CODING & REIMBURSEMENT CONSIDERATIONS ENDOSCOPIC ULTRASOUND NEEDLES

To help answer common coding and reimbursement questions, the following information is shared for educational and strategic planning purposes only. While Micro-Tech Endoscopy believes this information to be correct, please review the American Medical Association (AMA) CPT® Professional 2024 Codebook as well as payer requirements for appropriately selected patients.

REGULATORY CLEARANCE: The Endoscopic Ultrasound Needle (K212852, 12/6/21) is designed to sample targeted submucosal and extraluminal gastrointestinal lesions through the accessory channel of suitable ultrasound videoendoscope in adult patients only.

CODING CONSIDERATIONS: Codes provide a uniform language for describing services performed by healthcare providers. The actual selection of codes is the sole responsibility of the provider and is dependent upon details in the patient's medical record. Endoscopic Ultrasound (EUS) guided Fine Needle Aspiration (FNA) and Fine Needle Biopsy (FNB) are used by endoscopists to diagnose and stage various lesions located in and around the GI tract, for example, but not limited to:
